GENERAL INFORMATION

This Management's Discussion and Analysis ("**MD&A**") is management's interpretation of the results and financial condition of IsoEnergy Ltd. and its subsidiaries ("**IsoEnergy**" or the "**Company**") for the three and six months ended June 30, 2026 and includes events up to the date of this MD&A. This discussion should be read in conjunction with the unaudited condensed consolidated interim financial statements for the three and six months ended June 30, 2026 and 2025 and the notes thereto (the "**Interim Financial Statements**") and other corporate filings, including the Company's audited consolidated financial statements for the years ended December 31, 2025 and 2024 and the notes thereto (the "**Annual Financial Statements**") and the Annual Information Form for the year ended December 31, 2025 (the "**AIF**"), which have been filed on and are available under the Company's profile on SEDAR+ at www.sedarplus.ca and EDGAR at www.sec.gov. All dollar figures stated herein are expressed in Canadian dollars and referenced as "\$", unless otherwise specified. Monetary amounts expressed in US dollars and Australian dollars are referenced as "US\$" and "AUD\$", respectively. This MD&A contains forward-looking information. Please see "*Note Regarding Forward-Looking Information*" for a discussion of certain of the risks, uncertainties and assumptions used to develop the Company's forward-looking information.

Technical Disclosure

All scientific and technical information in this MD&A has been reviewed and approved by Dr. Dan Brisbin, P.Geo., Ph.D., IsoEnergy's Vice-President, Exploration. Dr. Brisbin is a "Qualified Person" for the purposes of National Instrument 43-101 - *Standards of Disclosure for Mineral Projects* ("**NI 43-101**"). Dr. Brisbin has verified the data disclosed, including sampling, analytical and test data.

All chemical analyses disclosed in this MD&A were completed for the Company by SRC Geoanalytical Laboratories in Saskatoon, Saskatchewan, which is independent of the Company.

All references in this MD&A to "Mineral Resource", "Inferred Mineral Resource", "Indicated Mineral Resource", and "Mineral Reserve" have the meanings ascribed to those terms by the Canadian Institute of Mining, Metallurgy and Petroleum, as the CIM Definition Standards on Mineral Resources and Mineral Reserves adopted by CIM Council, as amended.

Each of the Mineral Resource estimates with respect to the properties of IsoEnergy contained in this MD&A, except for the Larocque East Project and the Tony M Mine, are considered to be "historical estimates" as defined under NI 43-101 and are not considered to be current by IsoEnergy. See "*Historical Estimates*" for additional details.

Differences in United States and Canadian Reporting Practices

This MD&A has been prepared in accordance with the requirements of the securities laws in effect in Canada, which differ in certain material respects from the disclosure requirements promulgated by the Securities and Exchange Commission (the "**SEC**"). For example, the terms "mineral reserve", "proven

mineral reserve”, “probable mineral reserve”, “mineral resource”, “measured mineral resource”, “indicated mineral resource” and “inferred mineral resource” are Canadian mining terms as defined in accordance with NI 43-101 and the Canadian Institute of Mining, Metallurgy and Petroleum (the “**CIM**”) - *CIM Definition Standards on Mineral Resources and Mineral Reserves*, adopted by the CIM Council, as amended. These definitions differ from the definitions in the disclosure requirements promulgated by the SEC. Accordingly, information contained in this MD&A may not be comparable to similar information made public by US companies reporting pursuant to SEC disclosure requirements. The Company prepares its financial statements, which are referred to in this MD&A, in accordance with International Financial Reporting Standards (“**IFRS**”) as issued by the International Accounting Standards Board (“**IASB**”), and the audit of its annual financial statements is subject to auditing and independence standards of the Public Company Accounting Oversight Board in the United States.

Industry and Economic Factors that May Affect the Business

The business of mining for minerals involves a high degree of risk. IsoEnergy is an exploration and development company and is subject to risks and challenges similar to companies in a comparable stage and industry. These risks include, but are not limited to, the challenges of securing adequate capital; exploration, development and operational risks inherent in the mining industry; changes in government policies and regulations; the ability to obtain the necessary permitting; as well as global economic and uranium price volatility; all of which are uncertain.

As with other companies involved with mineral exploration and development, the Company is subject to cost inflation on exploration drilling and development activities and the Company may experience difficulty and / or delays in securing goods (including spare parts) and services from time-to-time.

The underlying value of the Company’s exploration and development assets is dependent upon the existence and economic recovery of Mineral Reserves and is subject to, among others, the risks and challenges identified above. Changes in future conditions could require material write-downs of the carrying value of the Company’s exploration and development assets. The Company does not have any current Mineral Reserves.

In particular, the Company does not generate revenue. As a result, IsoEnergy continues to be dependent on third party financing to continue exploration and development activities on the Company’s properties. Accordingly, the Company’s future performance will be most affected by its access to financing, whether debt, equity or other means. Access to such financing, in turn, is affected by general economic conditions, the price of uranium, exploration risks and the other factors some of which are described in the section entitled “*Risk Factors*” included below.

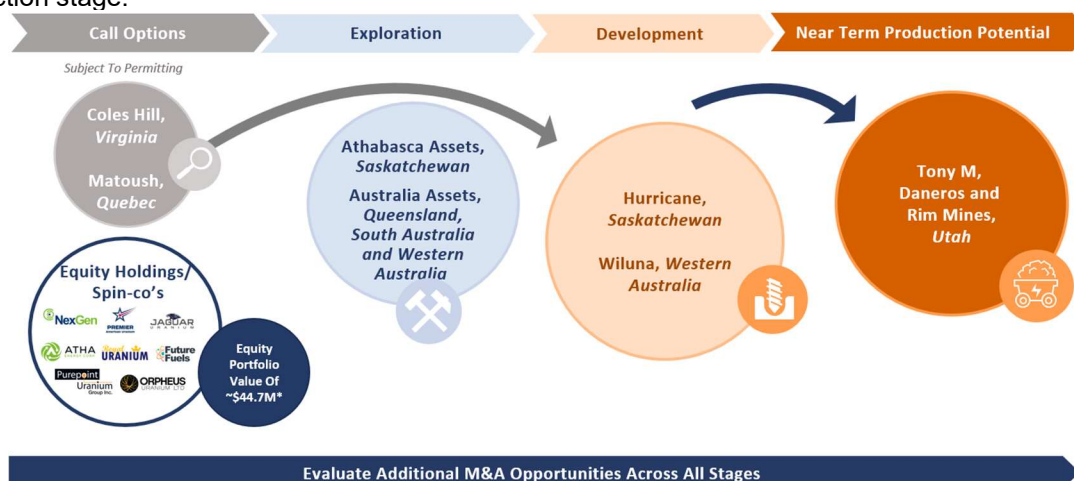
ABOUT ISOENERGY

IsoEnergy’s principal business activity is the acquisition, exploration and development of uranium mineral properties in Canada, the United States, and Australia. The Company’s common shares trade on the Toronto Stock Exchange (the “**TSX**”) under the trading symbol “ISO”, and as of May 5, 2025, trade on the NYSE American LLC (the “**NYSE American**”) under the trading symbol “ISOU”. The Company exists under the *Business Corporations Act (Ontario)*.

On March 20, 2025, the Company completed the consolidation of its issued and outstanding common shares on the basis of one post-consolidation common share for every four pre-consolidation common shares and any fractional shares were rounded down to the nearest whole common share (the “**Share Consolidation**”). The Share Consolidation was implemented in connection with the Company’s application to list its common shares on the NYSE American.

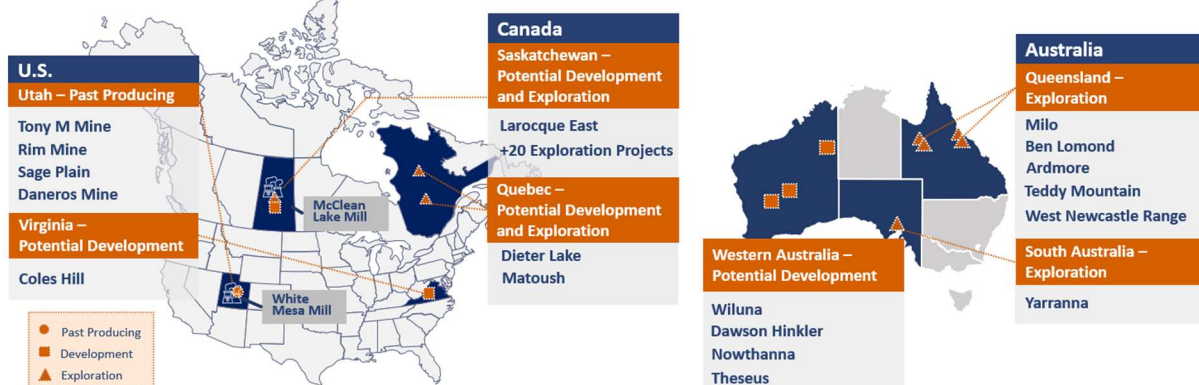
As of the date hereof, NexGen Energy Ltd. (“**NexGen**”) holds approximately 27.8% of IsoEnergy’s outstanding common shares.

The Company is currently advancing its Larocque East Project in the Athabasca Basin, Saskatchewan, Canada, which is home to the Hurricane deposit (“**Hurricane**” or the “**Hurricane Deposit**”), which has the world's highest grade published Indicated uranium Mineral Resource – 48.6 million pounds of U_3O_8 at an average grade of 34.5% contained in 63,800 tonnes. The Company also holds a portfolio of permitted, past-producing conventional uranium mines in Utah with toll milling agreements in place with Energy Fuels Inc. (“**Energy Fuels**”). These mines are currently on stand-by, ready for a potential restart as market conditions permit, positioning IsoEnergy as a near-term uranium producer. The Company also has a 50% interest in a joint venture with Purepoint Uranium Group Inc. (“**Purepoint Uranium**”), with respect to a portfolio of exploration projects in the Athabasca Basin (the “**Purepoint Joint Venture**”). The Company’s focus in Australia is advancing the Wiluna Project (“**Wiluna**”) in Western Australia, Australia, which hosts a Historic Mineral Resource¹ of 69.1 million pounds of U_3O_8 . The Company’s portfolio includes projects and equity holdings in companies with uranium assets at varying stages of exploration and development, providing near, medium, and long-term leverage to rising uranium prices. None of the Company’s projects are currently in production and no decisions have been made to bring any of the Company’s projects to the production stage.

As an exploration stage company, IsoEnergy does not have revenues and is expected to generate operating losses. As of June 30, 2026, the Company had cash and cash equivalents of \$122,865,833, an accumulated deficit of \$111,864,378, and adjusted working capital of \$160,889,782 (as defined in “*Non-IFRS Financial Measures*” below).

YEAR-TO-DATE 2026 HIGHLIGHTS

- **Exploration update in the Athabasca Basin and Utah**

A total of 6,804 metres of drilling in 17 diamond drill holes were completed for the 2026 winter exploration program at the Larocque East Project. The program focused on drilling at the Hurricane Deposit and testing greenfield targets up to three kilometres along the Larocque regional geological-geophysical corridor (the “**Larocque Trend**”) (Figure 2). The 2026 summer exploration program is currently underway with a total of 8,000 metres of drilling in 20 diamond drill holes planned. Mineralization was intersected in multiple holes along the South Trend of the Larocque East Project in the 2026 winter exploration program and the 2026 summer exploration program is focused on continued testing of this area.

The 2026 winter exploration program at the Dorado Project (“**Dorado**”), operated through the Purepoint Joint Venture, was completed comprised of nine holes totalling 5,210 metres which was successful in extending the uranium mineralization at the project. The 2026 summer exploration program at Dorado is underway with 3,150 metres planned in seven drill holes. The drilling program is focused on expanding the Nova Discovery while also evaluating high-priority regional targets across the broader Dorado Project.

The drilling program at the Flatiron Project has been completed with a total of seven surface rotary holes being drilled in 2026, totalling approximately 11,000 feet.

- **Commencement of key work programs at Tony M**

The Company completed the mining component of a bulk sample program, which is a critical step in defining the scope and economics of potential future production. The results of the bulk sample program are currently being evaluated, and its results are intended to be used as inputs in technical studies planned for 2026. The Tony M Mine remains fully permitted and the results of the completed bulk sample program and planned technical studies are expected to assist in the planning of future mining activities and the determination of a uranium price that may support mining activities at the Tony M Mine.

- **Base Shelf Prospectus**

The Company filed a final base shelf prospectus (the “**Prospectus**”) in Canada and a registration statement in the United States on January 13, 2026. The Prospectus provides for the offering up to \$250 million in aggregate of common shares, warrants, units, debt securities, and subscription receipts of the Company in Canada and the United States for a period of 25 months following the filing of the Prospectus.

- **2026 Financing and Concurrent Private Placement**

On January 27, 2026, the Company closed a “bought deal” financing whereby the Company issued 3,833,410 common shares at a price of \$15.00 per share for gross proceeds of approximately \$57.5 million (the “**2026 Financing**”). The underwriters were paid a cash commission of 5% of the gross proceeds of the 2026 Financing.

Concurrent with the 2026 Financing, the Company completed a non-brokered private placement whereby the Company issued 1,666,667 common shares to NexGen at a price of \$15.00 per share for gross proceeds of approximately \$25.0 million (the “**2026 Concurrent Private Placement**”). The 2026 Concurrent Private Placement enabled NexGen to maintain its pro-rata ownership interest in the Company.

- **Launch of At-The-Market equity program**

On April 17, 2026, the Company entered into an equity distribution agreement (the “**Distribution Agreement**”) with a group of agents (the “**Agents**”). The Distribution Agreement allows the Company to distribute up to \$50.0 million of its common shares, through the Agents, through the NYSE American or TSX (the “**ATM Program**”) at prices related to prevailing market prices or at negotiated prices.

- **Acquisition of Toro Energy Limited**

On June 25, 2026, the Company completed the acquisition of Toro Energy Limited (“**Toro Energy**”), a company previously listed on the Australian Securities Exchange (“**ASX**”), pursuant to a scheme of arrangement under Australia’s *Corporations Act 2001 (Cth)* (the “**Toro Scheme**”) for a share-for-share exchange whereby the Company acquired all of the issued and outstanding shares of Toro Energy (“**Toro Energy Shares**”) not already held by the Company. Pursuant to the Toro Scheme, Toro Energy shareholders received 0.036 of a common share of the Company for each Toro Energy Share held. In aggregate, the Company issued 4,403,296 common shares under the Toro Scheme.

The acquisition of Toro Energy expands the Company’s portfolio of uranium assets in Australia, highlighted by Wiluna as discussed above in “*About IsoEnergy*”. - **Sustainability Report**

On July 13, 2026, the Company released its sustainability report for the year ended December 31, 2025 (the “**Sustainability Report**”). The Sustainability Report highlights the Company’s continued progress in advancing its global uranium portfolio with a focus on environmental stewardship, Indigenous partnerships, empowering local talent, and responsible corporate governance. DISCUSSION OF OPERATIONS

Six months ended June 30, 2026

During the six months ended June 30, 2026, the Company incurred \$11,815,895 of exploration and evaluation spending on its exploration properties globally, as set out below. Most of the expenditures were at the Company's Larocque East Project in the Athabasca Basin as further discussed below. See "Outlook" below for future exploration plans.

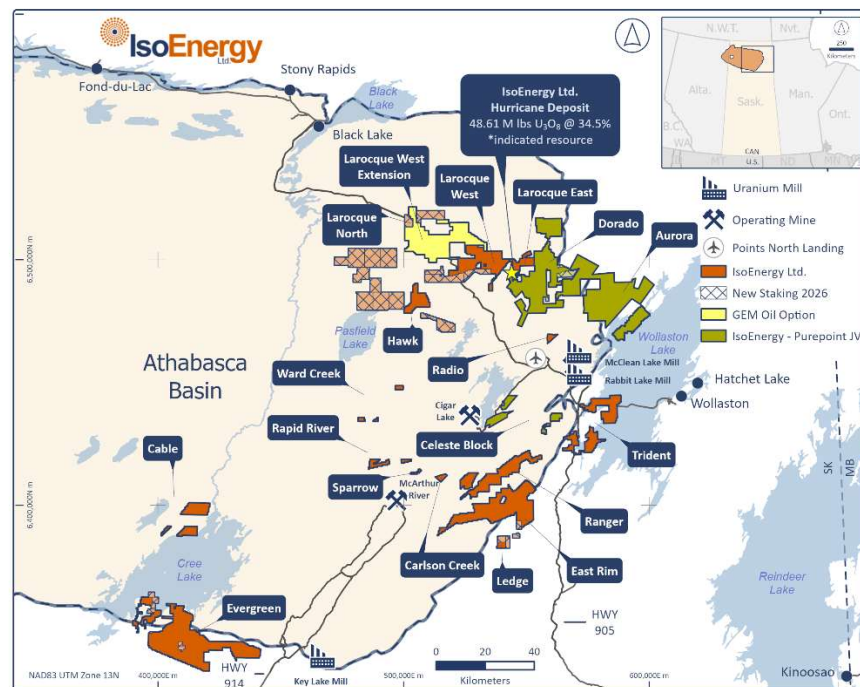

*Larocque East Project**Winter 2026 – Diamond Drilling*

The winter 2026 drilling program focused on testing resource expansion targets at the Hurricane Deposit and testing greenfield targets up to three kilometres east along the Larocque Trend. The Company initially planned for 13 diamond drill holes totalling 5,200 metres and successfully expanded the program to complete 17 diamond drill holes totalling 6,804 metres.

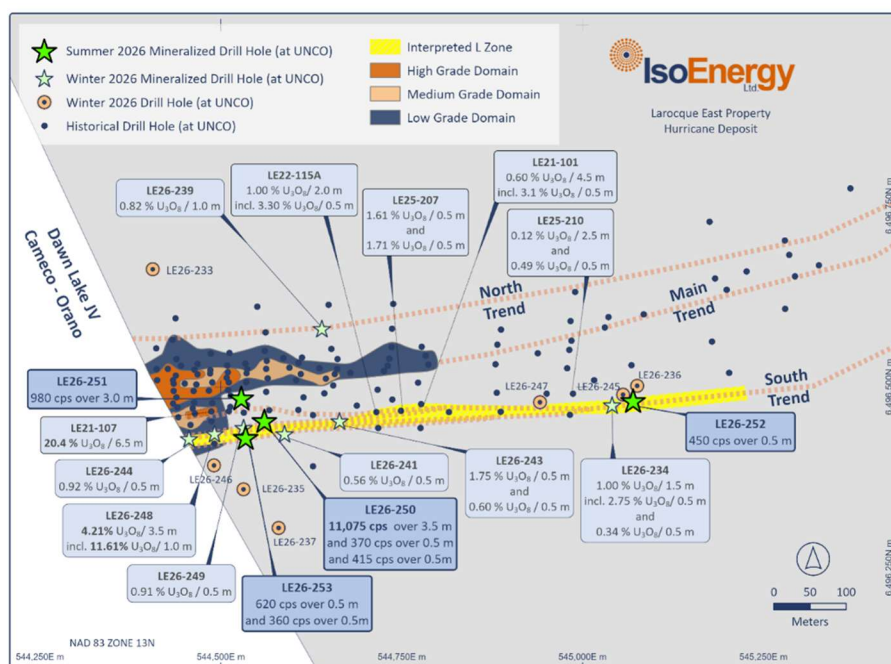
The winter 2026 drilling program focused on resource expansion targets along the North and South Trends. Uranium mineralization was intersected on both trends, which built upon intersections along these two trends from the 2025 exploration programs. Assay results from the winter 2026 drilling program include high-grade uranium mineralization intersected within the newly reinterpreted fault zone along the Hurricane South Trend (Figure 2).

The summer 2026 drilling program commenced on June 10, 2026, continuing to focus on expanding mineralization beyond the current resource footprint by targeting the Hurricane South Trend. It was temporarily suspended on June 26, 2026 following a precautionary evacuation due to nearby wildfires. Drilling fully resumed on July 8, 2026. The precautionary evacuation did not significantly affect the summer 2026 drilling program and the Company expects to complete its plan to drill 8,000 metres in up to 20 diamond drill holes in the summer 2026 drilling program.

The full suite of geochemical assays and structural interpretations of the summer 2026 drill program, once received, will be used to fully inform drill targets and exploration targets for future drill and exploration programs at Larocque East.

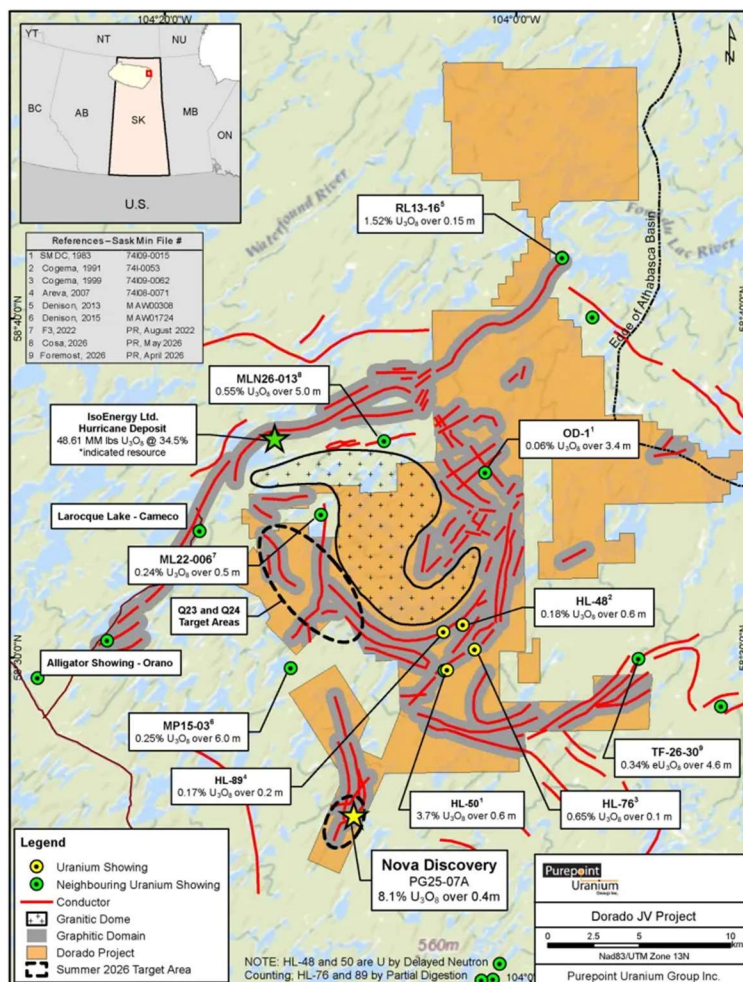
Dorado Project (Purepoint Joint Venture)

Winter 2026 – Drilling

The winter 2026 drilling program at Dorado, operated by Purepoint Uranium, was completed with nine holes totalling 5,210 metres. The winter 2026 drilling program focused on expanding the high-grade Nova Discovery and the holes drilled successfully expanded uranium mineralization at the Nova Discovery and extended the geologic contact for a strike length of one kilometre. This was highlighted by drill holes NV26-05 which had an average of 17,700 cps over 1.8 metres and NV26-03A which had an average of 10,600 cps over 1.7 metres. The winter 2026 drill program established a refined targeting framework for continued expansion. The summer 2026 drill program is focused on expanding the Nova Discovery and evaluating additional high-priority regional targets across Dorado. The summer 2026 drill program at Dorado is planned to comprise approximately 3,150 metres in seven drill holes (Figure 3).

Drilling at Dorado commenced in June 2026 and an airborne Mobile MagnetoTellurics (“**MobileMT**”) survey over the Dorado Project has been completed in 2026. Once the 2026 exploration programs at Dorado are completed and the full suite of geochemical assays and structural interpretations are received, the results will be used to fully inform future drill targets and exploration targets at the Dorado project.

Other Canadian projects

The majority of spending at other Canadian projects included completing MobileMT surveys at the Trident and Ranger projects in the Athabasca Basin, geological fieldwork at Matoush in Quebec, planning for 2026 fieldwork and reporting on 2025 fieldwork. The Company also spent \$500,000 extending its Larocque West project through an option agreement with GEM Oil Inc. and spent \$35,767 to stake several claims extensions along the Larocque East, Larocque West, Hawk, East Rim, Evergreen, and Ledge projects in the Athabasca Basin.

United States

Expenditure on the Company's properties in the United States during the six months ended June 30, 2026 was primarily at the Tony M Mine and Flatiron Project in Utah.

Tony M Mine

The Company completed a bulk sample program, which involved the extraction of approximately 2,100 tons of mineralized material. The bulk sample program was executed by the Company using contract mining services provided by GenX Mining Contractors, LLC. The results of the bulk sample program, once fully evaluated, are intended to be inputs into ongoing technical studies.

Flatiron Project

The Company completed its drilling program at the Flatiron Project in Utah. Seven surface rotary holes were drilled as planned. Once the full suite of geochemical assays and structural interpretations are received, the results will be used to fully inform future drill targets and exploration targets at the Flatiron Project.

Claim Staking and Claim Maintenance

The Company incurred \$350,561 in expenditure on annual state lease fees, advance royalties, other short-term lease payments, and land management fees related to the Company's properties in Utah during the six months ended June 30, 2026.

Year ended December 31, 2025

During the year ended December 31, 2025, the Company incurred \$24,392,910 of exploration and evaluation spending on its exploration properties globally, as set out below. Most of the expenditures were at the Company's Larocque East Project in the Athabasca Basin.

OUTLOOK

The Company intends to actively explore all its exploration projects as and when resources permit (other than at the Bulyea River project as discussed below in “*Summary of Quarterly Results*”). The nature and extent of further exploration on any of the Company’s properties, however, will depend on the results of completed and ongoing exploration activities, an assessment of the Company’s recently acquired properties and the Company’s financial resources.

Planned activities in Canada for 2026 include completing the drilling in the summer of 2026 at Larocque East, with the continued focus of testing resource expansion potential near the Hurricane Deposit and evaluating greenfield targets along the Larocque Trend, as further outlined in “*Discussion of Operations*” above. Other planned activities in Canada for 2026 include completing geophysical surveys and interpretation at the Larocque East, Larocque West, Evergreen, East Rim, and Hawk projects, and completing geological field work on the Evergreen and East Rim projects in the Athabasca Basin. Remaining activities at the Dorado Project, operated by Purepoint Uranium, include completing the summer drilling program. Once the evaluation of exploration results from the 2026 exploration programs are completed, this information will be used to propose future detailed exploration work.

The Company’s planned work program at the Tony M Mine in 2026 includes completing the analysis of the results of the bulk sample program. The Company has commenced a Preliminary Economic Assessment (“**PEA**”) in 2026 and will be incorporating the results from the bulk sample program. The PEA will provide an incentive uranium price for potential production and a basis for advancing detailed mine planning, finalizing potential restart sequencing, and assessing possible timing of a potential production decision. Activities in the US in 2026 also include completing the 2026 exploration programs at the Daneros and Sage Plain projects, in Utah.

Once the evaluation of exploration results from the 2026 exploration programs across the Company’s portfolio are completed, this information will be used to propose future detailed exploration work. The Company also intends to complete an NI 43-101 resource report for Wiluna and internal technical studies on certain non-material properties in 2026.

SELECTED FINANCIAL INFORMATION

Management is responsible for the Interim Financial Statements referred to in this MD&A. The Audit Committee of the Board of Directors (the “**Board**”) has been delegated the responsibility to review the Interim Financial Statements and MD&A and make recommendations to the Board. The Board is responsible for final approval of the Interim Financial Statements and MD&A.

The Interim Financial Statements have been prepared in accordance with IAS 34, *Interim Financial Reporting* (“**IAS 34**”) as issued by the IASB and interpretations of the International Financial Reporting Interpretations Committee (“**IFRIC**”). The Company’s presentation currency and the functional currency of its Canadian operations is Canadian dollars; the functional currency of its Australian operations is the Australian dollar; and the functional currency of its United States operations is the US dollar.

The Company’s Interim Financial Statements have been prepared using IFRS applicable to a going concern, which assumes that the Company will be able to realize its assets and discharge its liabilities in the normal course of business for the foreseeable future. The ability of the Company to continue as a going concern is dependent on its ability to obtain financing and achieve future profitable operations.

Financial Position

The following financial data is derived from and should be read in conjunction with the Interim Financial Statements and the Annual Financial Statements. As an exploration stage company, IsoEnergy does not have revenues.

In the six months ended June 30, 2026, the Company acquired Toro Energy which increased total assets by \$76,111,333 and exploration and evaluation assets by \$74,853,334. The Company also capitalized \$11,815,895 of exploration and evaluation costs, before movements in foreign exchange rates, as further described in “*Discussion of Operations*” above. Furthermore, total assets increased due to \$57,501,150 raised in the 2026 Financing and \$25,000,005 raised in the 2026 Concurrent Private Placement, with associated share issuance costs of \$4,031,076. Total assets also increased from the receipt of \$4,498,560 of common shares of Jaguar Uranium Corp. (“**Jaguar Uranium**”) as the remaining consideration pursuant to the sale of the Company’s Argentina assets that was completed in July 2024. Increases to total assets were partially offset by a decrease in the fair value of marketable securities of \$15,904,784 during the six months ended June 30, 2026.

Current liabilities as at June 30, 2026, include a flow-through share premium liability of \$2,184,168 relating to the February 2025 Financing (as defined herein). Accounts payable and accrued liabilities increased by \$6,088,557 during the six months ended June 30, 2026 mostly due to transaction costs incurred for the acquisition of Toro Energy. The fair value of the US\$4 million in principal of unsecured convertible debentures issued on December 6, 2022 (the “**2022 Debentures**”) increased by \$571,152 during the six months ended June 30, 2026. Adjusted working capital increased during the six months ended June 30, 2026 mainly due to the 2026 Financing and 2026 Concurrent Private Placement.

Acquisition of Toro Energy

On June 25, 2026, the Company completed the acquisition of Toro Energy. The Company issued 4,403,296 common shares under the Toro Scheme. See above in “Year-to-date 2026 Highlights” for further detail around the terms of the acquisition.

The acquisition of Toro Energy expands the Company’s uranium mineral footprint by entering a new jurisdiction in Western Australia, Australia. The most significant mineral property acquired is the Wiluna uranium project.

The closing price of the Company’s common shares on the TSX was \$14.55 on the date of issue.

Three months ended June 30, 2026

During the three months ended June 30, 2026, the Company recorded a net loss of \$6,689,958, compared to a net loss of \$1,887,270 in the three months ended June 30, 2025. The main driver of the difference between the two periods was the increase in share-based compensation as the Company granted more stock options in the current period as compared to the comparative period. Additionally, increased expenditure on investor relations and business development activities led to an increase in the net loss, which was partially offset by an increase in interest income related to the higher cash balances from the 2026 Financing and 2026 Concurrent Private Placement. Finally, in the prior period, the Company sold certain royalty assets and recorded a gain of \$820,394. Other factors causing the difference between the two periods are further described below.

General and administrative costs

Share-based compensation was \$2,794,974 in the three months ended June 30, 2026, compared to \$1,101,397 in the three months ended June 30, 2025. The share-based compensation expense is a non-cash charge based on the Black-Scholes value of stock options, calculated using the graded vesting method. Stock options granted to directors, consultants and employees typically vest in three tranches – 1/3 immediately, 1/3 on the first anniversary of the grant date, and the remaining 1/3 on the second anniversary of the grant date, with the corresponding share-based compensation expense being recognized over this period. The increase in the current period was primarily due to stock options granted during the current period compared to none in the comparative period.

Salaries, contractor and director fees increased from the prior period primarily due to the addition of the Vice President, Strategy and Commercial in the three months ended December 31, 2025.

Investor relations expenses relate primarily to costs incurred in communicating with existing and potential shareholders, conferences and marketing. The increase in the current period is primarily due to additional marketing activities in the United States, Europe, and Asia, as well as an investor site tour at Tony M.

Office and administrative expenses primarily consist of office operating costs and other general administrative costs. The increase in the current period as compared to the prior period is primarily due to an increase in IT security related expenditures.

Professional and consultant fees were higher than the prior period mainly due to higher business development expenditures during the three months ended June 30, 2026.

Travel expenses primarily relate to travel and accommodation costs for conferences, business development activities, public relations activities, and general corporate purposes. Travel costs increased in the three months ended June 30, 2026 as the Company continues to expand its marketing activities in the United States, Europe and Asia.

Public company costs consist primarily of costs associated with the Company's continuous disclosure obligations, listing fees, directors and officers insurance, transfer agent costs, press releases and other shareholder communications. The decrease in public company costs is primarily due to the initial listing fees for the NYSE American incurred in the prior period.

Other items

Interest expense on the Debentures (as defined herein) was \$138,435 in the three months ended June 30, 2026, which decreased from \$226,594 in the three months ended June 30, 2025. The 2022 Debentures bear interest of 10% per annum and are payable, with a combination of cash and common shares of the Company, on June 30 and December 31. The decrease is primarily due to the US\$6 million principal of unsecured convertible debentures issued on August 18, 2020 (the "**2020 Debentures**") and together with the 2022 Debentures, the "**Debentures**") being fully converted by August 1, 2025.

The fair value of the 2022 Debentures on June 30, 2026 was \$6,002,011 compared to \$6,004,955 on March 31, 2026. The decrease in fair value includes \$8,165 recorded in the statement of income and partially offset by a fair value increase attributable to the change in credit risk of \$5,221 included in other comprehensive income (loss). The 2022 Debentures are classified as measured at fair value through profit and loss. In accordance with IFRS 9 – Financial Instruments, the part of a fair value change due to an entity's own credit risk is presented in other comprehensive income (loss). As of June 30, 2026, the time to maturity of the 2022 Debentures was 1.4 years.

Foreign exchange loss was \$34,623 in the three months ended June 30, 2026, compared to a loss of \$75,864 in the three months ended June 30, 2025, and mainly relates to negative exchange movements on accounts payable denominated in United States dollars held by the Company.

Other income was \$25,676 in the three months ended June 30, 2026, compared to \$92,020 in the three months ended June 30, 2025. This primarily relates to incidental timber sales earned from the Company's operations in the US in the prior period, of which fewer such sales occurred in the current period.

The Company records a deferred tax recovery or expense which is comprised of a recovery on losses or expense on gains recognized in the period and, when applicable, the release of flow-through share premium liability which is offset by the renunciation of flow-through share expenditures to shareholders. In the three months ended June 30, 2026, this resulted in an expense of \$80,581, compared to a recovery of \$491,348 in the three months ended June 30, 2025. The increase in expense is mostly due to a lower proportion of flow-through share eligible expenditures compared to the prior period.

Six months ended June 30, 2026

During the six months ended June 30, 2026, the Company recorded a net loss of \$8,192,733, compared to net income of \$3,218,345 in the six months ended June 30, 2025. The main driver of the difference between the two periods was a gain on disposal of \$4,498,560 recorded in the current period from the receipt of the remaining consideration from the sale of the Argentina reporting segment, which was accounted for as a contingent asset until it was received, compared to a gain of \$10,369,031 recorded in the prior period relating to the sale of the Mountain Lake property. The decrease from net income in the prior period to a net loss in the current period was also due to an increase in general and administrative costs of \$4,388,183, as further described below. Other factors causing the difference between the two periods, other than those that are for similar reasons discussed above for the three months ended June 30, 2026, are further described below.

General and administrative costs

The increase in public company costs is primarily due to the additional costs of sustaining a listing on the NYSE American, including the amortization of the premium for additional Director and Officer insurance, partially offset by the initial listing fees for the NYSE American incurred in the prior period.

Other items

The fair value of the 2022 Debentures on June 30, 2026 was \$6,002,011 compared to \$5,430,859 on December 31, 2025. The increase in fair value includes \$565,447 recorded in the statement of income and a fair value increase attributable to the change in credit risk of \$5,705 included in other comprehensive loss.

Foreign exchange gain was \$114,772 in the six months ended June 30, 2026, compared to a loss of \$68,945 in the six months ended June 30, 2025, and mainly relates to exchange movements on an increased cash balance denominated in United States dollars held by the Company.

Other income was \$44,916 in the six months ended June 30, 2026, compared to \$523,941 in the six months ended June 30, 2025. This primarily relates to incidental timber sales earned from the Company's operations in the US in the prior period, of which fewer such sales occurred in the current period.

In the six months ended June 30, 2026, a deferred income tax expense of \$713,632 was recorded, compared to an expense of \$339,523 in the six months ended June 30, 2025. The increase in expense is mostly due to a lower temporary difference in exploration and evaluation assets in the current period compared to the prior period as a result of renouncing all flow-through share expenditures from the February 2025 Financing in the year ended December 31, 2025.

IsoEnergy does not derive any revenue from its operations. Its primary focus is the acquisition, exploration and development of mineral properties. As a result, the income (loss) per period has fluctuated depending on the Company's activity level and periodic variances in certain items. Quarterly periods are therefore not comparable. As part of the Company's strategy to evaluate additional Merger and Acquisition ("M&A") opportunities, the Company may incur gains or losses related to such transactions or incur expenses for M&A opportunities that do not materialize. In the three months ended March 31, 2026, a gain of \$4,498,560 was recorded on the receipt of common shares of Jaguar Uranium as the remaining consideration pursuant to the sale of the Argentina reporting segment; in the three months ended December 31, 2025, a gain of \$2,250,000 was recorded on the receipt of common shares of Future Fuels as the remaining consideration pursuant to the sale of the Mountain Lake property; in the three months ended June 30, 2025, a gain of \$820,394 was recorded on the sale of certain of the Company's royalty assets; in the three months ended March 31, 2025, a \$10,369,031 gain was recorded on the sale of the Mountain Lake property; in the three months ended December 31, 2024, a loss of \$25,616,241 was recorded from the contribution of exploration and evaluation assets to the Purepoint Joint Venture; and in the three months ended September 30, 2024, a \$5,300,611 gain was recorded on the disposal of its Argentina assets.

The Company also assesses for indicators of impairment on its property and equipment and exploration and evaluation assets quarterly, as required by the relevant IFRS. If such indicators are identified, an analysis to determine its recoverable value is performed and if such amount is lower than the carrying value, a loss is recognized for the difference. In the three months ended December 31, 2025, the Company expected to not currently continue exploration work at its Bulyea River property and recorded a write-down of \$935,814. In the three months ended December 31, 2024, the Company identified indicators of impairment on certain exploration and evaluation assets located in the Athabasca Basin primarily as a result of the loss on the formation of the Purepoint Joint Venture and recorded a write-down of \$14,342,736.

In the third quarter of 2020, the Company issued the 2020 Debentures and in the fourth quarter of 2022 issued the 2022 Debentures, both of which were and are, respectively, accounted for as measured at fair value through profit and loss, which has resulted in a gain on the revaluation of the Debentures in the three months ended September 30, 2024, three months ended December 31, 2024, three months ended June 30, 2025, three months ended September 30, 2025, three months ended December 31, 2025, three months ended June 30, 2026, and losses in every other period.

LIQUIDITY AND CAPITAL RESOURCES

IsoEnergy has no revenue-producing operations, earns only minimal interest income on cash, and is expected to have recurring operating losses. As of June 30, 2026, the Company had an accumulated deficit of \$111,864,378.

During the six months ended June 30, 2026, the Company utilized cash on hand to invest \$2,800,237 to complete the acquisition of Toro Energy (net of cash acquired), invest \$9,976,011 (net of changes in accounts payable) in exploration and evaluation assets, \$6,465,255 for expenditure on its corporate and business development activities, including movements in working capital, and spent \$3,302,789 (net of proceeds from disposals) to invest in common shares and/or warrants of marketable securities.

During the six months ended June 30, 2026, the Company received \$78,470,079 in net proceeds from the 2026 Financing and the 2026 Concurrent Private Placement, as well as \$4,613,804 on proceeds from exercises of stock options.

As of the date of this MD&A, the Company has approximately \$117.3 million in cash, \$41.8 million in marketable securities and \$154.4 million in adjusted working capital.

The Company has fully funded its planned global exploration and pre-development activities, as well as any corporate initiatives and general working capital, up to the end of December 31, 2026. This includes funding approved future expenditures on the properties acquired from Toro Energy. The ability of the Company to continue as a going concern is dependent on its ability to obtain financing and achieve future profitable operations.

Should the Company require additional financing under its Prospectus or otherwise, Management will determine whether to accept any offer to finance, weighing such factors as the financing terms, the results of exploration programs and technical studies, the Company's share price at the time and current market conditions, among others.

Circumstances that could impair the Company's ability to raise additional funds include general economic conditions, the price of uranium and certain other factors set forth under "*Risk Factors*" below and above under "*Industry and Economic Factors that May Affect the Business*". A failure to obtain financing as and when required, could require the Company to reduce its exploration and corporate activity levels.

Use of Proceeds

On February 9, 2024, the Company completed a brokered “bought-deal” private placement for gross proceeds of \$23.0 million (the “**February 2024 Private Placement**”). The proceeds from the February 2024 Private Placement were required to be and were spent on eligible “Canadian exploration expenses” that qualify as “flow-through critical mineral mining expenditures” by December 31, 2025.

On February 28, 2025, the Company completed a “bought deal” financing whereby the Company issued 1,333,825 “flow-through” common shares⁽¹⁾ at a price of \$15.00 per share, for gross proceeds of approximately \$20.0 million (the “**February 2025 Financing**”). Concurrent with the February 2025 Financing, the Company completed a non-brokered private placement whereby the Company issued 625,000 common shares⁽¹⁾ to NexGen for gross proceeds of approximately \$6.3 million (the “**2025 Concurrent Private Placement**”). On June 24, 2025, the Company closed a “bought deal” financing whereby the Company issued 5,121,500 common shares at a price of \$10.00 per share for gross proceeds of approximately \$51.2 million (the “**June 2025 Financing**”). The proceeds from the February 2025 Financing are required to be spent on eligible “Canadian exploration expenses” that qualify as “flow-through critical mineral mining expenditures” (in each case as defined in the Income Tax Act (Canada) (the “**Tax Act**”)) by December 31, 2026 and the Company was required to and did renounce the full amount of the gross proceeds of the financing to the subscribers of the flow-through shares no later than December 31, 2025. The proceeds of 2025 Concurrent Private Placement were to be used for other non-qualifying expenditures on the exploration of the Company’s Canadian properties, costs associated with the listing on the NYSE American, and for working capital and general corporate purposes. The proceeds of the June 2025 Financing are expected to be used to fund continued development and further exploration of the Company’s mineral properties, and for general corporate purposes.

On January 27, 2026, the Company received total gross proceeds of \$82.5 million from the 2026 Financing and 2026 Concurrent Private Placement. The proceeds of these two financings are expected to be used to fund continued development and further exploration of the Company’s mineral properties, corporate development activities and investments, and for general corporate purposes.

The Company's properties are in good standing with applicable governmental authorities. Other than the contractually agreed upon exploration budget in 2026 for the Purepoint Joint Venture, the Company does not have any contractually imposed expenditure requirements.

The Company has not paid any dividends and management does not expect that this will change in the near future. Working capital is mainly held in cash, cash deposits available on short-term demand, and marketable securities, all of which are highly liquid.

The Company expects to utilize cash and cash equivalents on hand to settle the above noted commitments and contingencies, should any of the contingencies materialize.

Flow-through funding commitments

The Company has raised funds through the issuance of flow-through shares. Based on Canadian tax law, the Company is required to spend this amount on eligible exploration expenditures by December 31 of the year following the year in which the shares were issued.

The premium received for a flow-through share, which is the price received for the share in excess of the market price of the share, is recorded as a flow-through share premium liability. This liability is subsequently reduced when the required exploration expenditures are made, on a pro rata basis, and accordingly, a recovery of flow-through premium is then recorded as a reduction in the deferred tax expense to the extent that deferred income tax assets are available.

The Company issued flow-through shares on February 9, 2024 for gross proceeds of \$23,000,000 and subsequently incurred \$23,000,000 in eligible exploration expenditures in the period up to December 31, 2025, fulfilling the Company's obligation to spend the funds raised on eligible exploration expenditures. As the commitment is fully satisfied, the remaining balance of the flow-through share premium liability was derecognized in 2025.

The Company issued flow-through shares on February 28, 2025 for gross proceeds of \$20,007,375 and has incurred \$14,546,958 in eligible exploration expenditures up to June 30, 2026. As of June 30, 2026, the Company is obligated to spend \$5,460,417 on eligible exploration expenditures by December 31, 2026.

Contingent payment obligations

The Company has an obligation to make a contingent payment of \$500,000 related to the acquisition of the West Newcastle Range, Teddy Mountain and Ardmore East Projects, if either of the following milestones are met by 2030:

- a NI 43-101 compliant Mineral Resource estimate for the West Newcastle Range and Teddy Mountain Projects is prepared where the Mineral Resource estimate is greater than or equal to 6.0 million pounds of U₃O₈; or
- with respect to the Ardmore East Project, the Mineral Resources estimate is greater than or equal to 6.0 million pounds of U₃O₈ equivalent.

Royalties and environmental obligations

In addition to applicable federal, provincial/state and municipal severance taxes, duties and advance royalties, the Company's exploration and evaluation properties are subject to certain royalties and contingent production payments, which may or may not be payable in future, depending on whether revenue is derived from the claims or leases to which these royalties are applicable.

The Company's mining and exploration activities are subject to various laws and regulations governing the protection of the environment. These laws and regulations are continually changing and generally becoming more restrictive. The Company believes its operations are materially in compliance with all applicable laws and regulations. The Company has made, and expects to make in the future, expenditures to comply with such laws and regulations.

Contractual arrangements

Pursuant to the acquisition of an option to explore an area that extends the Company's Larocque West property, the Company will be required to spend a further \$3,907,665 on exploration and assessment work. The agreement also requires the Company to make further option payments of \$250,000 in cash and \$750,000 in common shares on or before June 24, 2028 and \$500,000 in cash and \$1,500,000 in common shares on or before June 24, 2029.

The ownership interests of each party to the Purepoint Joint Venture are subject to standard dilution if either party fails to contribute to approved programs or expenditures of the Joint Venture Properties. If either party's interest is reduced to 10% or less, then that party will relinquish its entire interest in the Purepoint Joint Venture in exchange for a 2% NSR royalty on the Joint Venture Properties. The remaining party can purchase 1% of the NSR royalty for \$2.0 million.

OUTSTANDING SHARE DATA

The authorized capital of IsoEnergy consists of an unlimited number of common shares. As of the date of this MD&A, there were 65,256,428 common shares, 5,530,783 stock options, and 145,833 RSUs outstanding, each stock option entitling the holder to purchase one common share of IsoEnergy and each RSU representing the right of the holder to receive one common share upon vesting.

During the six months ended June 30, 2026, the Company issued 5,500,077 common shares for gross proceeds of \$82,501,155 pursuant to the 2026 Financing and 2026 Concurrent Private Placement; issued 375,804 common shares on the exercise of stock options for proceeds of \$4,613,804; issued 4,403,296 common shares pursuant to the Toro Energy acquisition valued at \$64,067,957; issued 28,881 common shares for advisory services related to the Toro Energy acquisition valued at \$400,002; and, 4,405 common shares valued at \$70,216 for the payment of interest. The Company granted 1,502,250 stock options at an average exercise price of \$13.37.

The 2022 Debentures issued to Queen's Road Capital Investment Ltd. bear a 10% coupon rate and are convertible at \$17.32 per share. The Company has US\$4 million principal remaining outstanding of the 2022 Debentures which mature on December 6, 2027.

CRITICAL ACCOUNTING JUDGMENTS, ESTIMATES AND ASSUMPTIONS

The preparation of the Interim Financial Statements requires management to make judgments, estimates and assumptions that affect the reported amounts of assets, liabilities, and contingent liabilities at the date of the Interim Financial Statements and the reported amounts of revenues and expenses during the reporting period. Estimates and assumptions are continuously evaluated and are based on management's experience and other factors, including expectations of future events that are believed to be reasonable in the circumstances. Uncertainty about these judgments, estimates and assumptions could result in outcomes that require a material adjustment to the carrying amount of the asset or liability affected in future periods. Information about significant areas of judgement, estimation uncertainty and assumptions considered by management in preparing the Interim Financial Statements are the same as described in the Annual Financial Statements or in the Interim Financial Statements.

CHANGES IN ACCOUNTING POLICIES INCLUDING INITIAL ADOPTION

The Interim Financial Statements were prepared in accordance with IAS 34 and its interpretations adopted by the IASB, and follow the same accounting policies and methods as described in the Annual Financial Statements.

The following standard has been issued and is effective:

Amendments to IFRS 9 and IFRS 7 – Classification and Measurement of Financial Instruments

In May 2024, the IASB issued 'Amendments to the Classification and Measurement of Financial Instruments (Amendments to IFRS 9 and IFRS 7)'. The amendments clarify the date of recognition and derecognition of some financial assets and financial liabilities, with a new exception that permits companies to elect to derecognize certain financial liabilities settled via electronic payment systems earlier than the settlement date. The amendments apply for annual reporting periods beginning on or after January 1, 2026, and are applied retrospectively. There were no changes to the Interim Financial Statements from adopting these amendments.

The following new standard has been issued and is not yet effective:

IFRS 18 – Presentation and Disclosure in Financial Statements

The IASB has issued IFRS 18 – *Presentation and Disclosure in Financial Statements* ("IFRS 18"), which replaces IAS 1 – *Presentation of Financial Statements*. IFRS 18 introduces new requirements for the presentation of financial performance, including revised categories in the statements of loss, enhanced disclosures on management-defined performance measures, and greater consistency in financial statement presentation. The standard is effective for annual reporting periods beginning on or after January 1, 2027 and applies retrospectively, with early adoption permitted.

The Company has not early adopted IFRS 18 and continues to evaluate the impact of the forthcoming standard in preparing the Interim Financial Statements.

CAPITAL MANAGEMENT AND RESOURCES

The Company manages its capital structure, defined as total equity plus debt, and adjusts it, based on the funds available to the Company, in order to support the acquisition, exploration and evaluation of assets. The Board does not impose quantitative return on capital criteria for management, but rather relies on the expertise of the Company's management to sustain the future development of the business.

In the management of capital, the Company considers all types of funding alternatives, including equity, debt and other means and is dependent on third party financing. Although the Company has been successful in raising funds to date, there is no assurance that the Company will be successful in obtaining required financing in the future or that such financing will be available on terms acceptable to the Company.

The properties in which the Company currently has an interest are in the exploration and development stage. As such the Company, has historically relied on the equity markets to fund its activities. The Company will continue to assess new properties and seek to acquire an interest in additional properties if it determines that there is sufficient geologic or economic potential and if it has adequate financial resources to do so.

Management reviews its capital management approach on an on-going basis and believes that this approach, given the relative size of the Company, is reasonable. The Company is not subject to externally imposed capital requirements. There were no changes in the Company's approach to capital management during the period.

FINANCIAL INSTRUMENTS

The Company's financial instruments consist of cash and cash equivalents, accounts receivable, marketable securities, accounts payable and accrued liabilities, and convertible debentures.

Fair Value Measurement

The Company classifies the fair value of financial instruments according to the following hierarchy based on the amount of observable inputs used to value the instrument:

- Level 1 – quoted prices in active markets for identical assets or liabilities.
- Level 2 – inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly (i.e. as prices) or indirectly (i.e. derived from prices).
- Level 3 – inputs for the asset or liability that are not based on observable market data.

The fair values of the Company's cash and cash equivalents, accounts receivable, and accounts payable and accrued liabilities approximate their carrying value, due to their short-term maturities or liquidity.

The 2022 Debentures are re-measured at fair value at each reporting date with any change in fair value recognized in profit or loss, except for the change in fair value that is attributable to change in credit risk, which is presented in other comprehensive income (loss). The 2022 Debentures are classified as Level 2.

The marketable securities are re-measured at fair value at each reporting date with any change in fair value recognized in other comprehensive income (loss). The common shares included in marketable securities are Level 1, except for the common shares of privately held marketable securities, which are Level 3 and their fair value is primarily based on the price of their most recent share issuances. The warrants included in marketable securities are Level 2.

During the six months ended June 30, 2026, certain of the investees in marketable securities completed a transaction to publicly list. As a result, the Company transferred its common shares held in these entities from Level 3 to Level 1. The fair value transferred is measured at the share price at the time of the public listing of each entity.

Financial instrument risk exposure

As of June 30, 2026, the Company's financial instrument risk exposure and the impact thereof on the Company's financial instruments are summarized below:

(a) Credit Risk

Credit risk is the risk that one party to a financial instrument will fail to discharge an obligation and cause the other party to incur a financial loss. As at June 30, 2026, the Company has cash and cash equivalents on deposit with large banks in Canada, the United States, and Australia. Credit risk is concentrated as a significant amount of the Company's cash and cash equivalents is held at a Canadian financial institution. Management believes the risk of loss to be remote.

The Company's accounts receivable mostly consists of input tax credits receivable from the Governments of Canada and Australia and amounts receivable from related parties. Accordingly, the Company does not believe it is subject to significant credit risk.

(b) Liquidity Risk

Liquidity risk is the risk that an entity will encounter difficulty in raising funds to meet its obligations under financial instruments. The Company manages liquidity risk by maintaining sufficient cash balances that are accessible on deposit or on short-term notice. Liquidity requirements are managed based on expected cash flows to ensure that there is sufficient capital to meet short-term obligations. As at June 30, 2026, the Company had an adjusted working capital balance of \$160,889,782, including cash and cash equivalents of \$122,865,833.

(c) Market Risk

Market risk is the risk of loss that may arise from changes in market factors such as interest rates, foreign exchange rates and commodity and equity prices.

(i) Interest Rate Risk

Interest rate risk is the risk that the future cash flows from a financial instrument will fluctuate due to changes in market interest rates. The Company holds its cash and cash equivalents in bank accounts that earn variable interest rates. Due to the short-term nature of these financial instruments, fluctuations in market rates do not have a significant impact on the estimated fair value of the Company's cash and cash equivalent balances as of June 30, 2026. The interest on the 2022 Debentures is fixed and not subject to market fluctuations.

(ii) Price Risk

The Company is exposed to price risk with respect to commodity and equity prices. Equity price risk is defined as the potential adverse impact of movements in individual equity prices or general movements in the level of the stock market on the Company's financial performance. Commodity price risk is defined as the potential adverse impact of commodity price movements and volatilities on financial performance and economic value. Future declines in commodity prices may impact the valuation of long-lived assets. The Company closely monitors the commodity prices of uranium, individual equity movements, and the stock market. The Company holds marketable securities which are subject to equity price risk.

(iii) Foreign Currency Risk

The Company enters into transactions denominated in foreign currencies from time-to-time and in addition to Canada, the Company operates in the United States and Australia, and is therefore exposed to foreign exchange risk arising from transactions denominated in foreign currencies. Foreign exchange risk arises when future commercial transactions or recognized assets or

liabilities are denominated in a currency that is not the Company's functional currency. Consequently, fluctuations of the Canadian dollar in relation to other currencies impact the fair value of financial assets, liabilities and operating results. Financial instruments subject to foreign currency risk include US dollar and Australian dollar denominated cash, US dollar and Australian dollar accounts receivable, US dollar and Australian dollar marketable securities, US dollar and Australian dollar accounts payable and accrued liabilities, and the 2022 Debentures. The Company maintains Canadian, US and Australian dollar bank accounts.

The Company is exposed to foreign exchange risk on its US dollar denominated cash, accounts payable and accrued liabilities, accounts receivable, marketable securities and 2022 Debentures. At its maturity date, the principal amount of the 2022 Debentures is due in full, and prior to then at a premium upon the occurrence of certain events, including a change of control. The Company holds sufficient US dollars to make all cash interest payments due under the 2022 Debentures until maturity and to pay the principal amount. The Company is subject to risks associated with fluctuations in the Canadian/US dollar exchange rate that may make the 2022 Debentures more costly to repay.

A 5% change in the Canadian/US dollar exchange rate can result in a net increase or decrease in the Company's US dollar denominated financial instruments of \$693,302 that would flow through the consolidated statement of income and comprehensive (loss) income.

The Company is exposed to foreign exchange risk on its Australian dollar denominated cash, accounts receivable, marketable securities, and accounts payable and accrued liabilities. Accordingly, the Company is subject to risks associated with fluctuations in the Canadian/Australian dollar exchange rate that may impact on its operating results.

A 5% change in the Canadian/Australian dollar exchange rate can result in a net increase or decrease in the Company's Australian dollar denominated financial instruments by \$148,386 that would flow through consolidated statement of income and comprehensive (loss) income.

RISK FACTORS

The operations of the Company are speculative due to the high-risk nature of its business which is the exploration and development of mineral properties.

Regulatory Factors and International Trade Restrictions

The international uranium industry, including the supply of uranium concentrates, is relatively small, highly competitive and heavily regulated. Worldwide demand for uranium is directly tied to the demand for electricity produced by the nuclear power industry, which is also subject to extensive government regulation and policies. The development of mines and related facilities is contingent upon governmental approvals that are complex and time consuming to obtain and which, depending upon the location of the project, involve multiple governmental agencies. The duration and success of such approvals are subject to many variables outside of the Company's control. Any significant delays in obtaining or renewing such permits or licences in the future could have a material adverse effect on the Company.

In addition, the international marketing and trade of uranium is subject to potential changes in governmental policies, regulatory requirements and international trade restrictions (including trade agreements, customs, duties and taxes), which are beyond the control of the Company. Changes in regulatory requirements, customs, duties or taxes may affect the supply of uranium to the United States and Europe, which are currently the largest consumption markets for uranium in the world, as well as the future of supply to developing markets, such as China and India.

The supply of uranium is, to some extent, impeded by a number of international trade agreements and policies. These and any similar future agreements, governmental legislation, policies or trade restrictions are beyond the Company's control and may affect the supply of uranium available in the United States, Europe and Asia, the world's largest markets for uranium. If the Company achieves commercial production but is unable to supply uranium to important markets in the United States or Europe, its business, financial condition and results of operations may be materially adversely affected. In addition, there can be no assurance that governments will not enact legislation or take other actions that restricts who can buy or supply uranium, which may have a material adverse effect on the price of uranium and the Company's financial condition and results of operations.

In particular, pursuant to an executive order, the United States has enacted significant new import tariffs on certain trade and transactions with Canada and other trading partners. Canada has enacted retaliatory import tariffs on certain trade and transactions from the United States. There is significant uncertainty surrounding further changes in governmental policy, particularly with respect to such trade policies, treaties and tariffs. These developments, and any similar further changes in governmental policy, may have a material adverse effect on global economic conditions and financial markets. The full economic impact of any such changes in governmental policy on the Company remains uncertain and is dependent on the severity and duration of the tariffs and any other measures imposed which, if prolonged, could increase costs and decrease demand for any minerals that may be extracted by the Company.

For a comprehensive list of the risks and uncertainties facing the Company, please see "*Risk Factors*" in the Company's AIF and the "*Industry and Economic Factors that May Affect the Business*" included above in the Overall Performance section of this MD&A. These are not the only risks and uncertainties that the Company faces. Additional risks and uncertainties not presently known to the Company or that the Company currently considers immaterial may also impair its business operations. These risk factors could materially affect the Company's future operating results and could cause actual events to differ materially from those described in forward-looking statements relating to the Company. Further risk factors are discussed in more detail in the Company's AIF.

Each of the Mineral Resource estimates contained in this MD&A, except for the Larocque East Project and Tony M Mine, are considered to be "historical estimates" as defined under NI 43-101, and have been sourced as follows:

The historical estimate was prepared in accordance with the 2012 Edition of the Australasian Code for Reporting of Exploration Results, Mineral Resources and Ore Reserves (JORC Code 2012).*

In each instance, the historical estimate is reported using the categories of Mineral Resources and Mineral Reserves as defined by the Canadian Institute CIM Definition Standards for Mineral Reserves, and Mineral Reserves at that time, and these "historical estimates" are not considered by IsoEnergy to be current. In each instance, the reliability of the historical estimate is considered reasonable, but a Qualified Person has not done sufficient work to classify the historical estimate as a current Mineral Resource, and IsoEnergy is not treating the historical estimate as a current Mineral Resource. The historical information provides an indication of the exploration potential of the properties but may not be representative of expected results.

For the Daneros Mine, as disclosed in the above noted technical report, the historical estimate was prepared by Energy Fuels using a wireframe model of the mineralized zone based on an outside bound of a 0.05% eU₃O₈ grade cutoff at a minimum thickness of 1 foot. Surface drilling would need to be conducted to confirm resources and connectivity of resources in order to verify the Daneros historical estimate as a current Mineral Resource.

For the Sage Plain Project, as disclosed in the above noted technical report, the historical estimate was prepared by Peters Geosciences using a modified polygonal method. An exploration program would need to be conducted, including twinning of historical drill holes, in order to verify the Sage Plain historical estimate as a current Mineral Resource.

For the Coles Hill Project, as disclosed in the above noted revised preliminary economic assessment, the historical estimated was prepared by John I Kyle of Lyntek Incorporated. Twinning of a selection of certain holes would need to be completed along with updating of mining, processing and certain cost estimates in order to verify the Coles Hill Project historical resource estimate as a current Mineral Resource estimate.

For Dieter Lake, as disclosed in the above noted technical report, the historical estimate was prepared by Davis & Guo using the Thiessen (Voronoi) polygon method. Data constraints used were 200 ppm, 500 ppm, and 1000ppm U₃O₈ over a minimum of 1 metre thickness. Polygons created had radii of 200 metres. A rock density of 2.67g/cm³ was used. An exploration program would need to be completed, including twinning of historical drill holes, in order to verify the Dieter Lake historical estimate as a current Mineral Resource.

For Matoush, as disclosed in the above noted press release, the historical estimate was prepared by RPA using block U₃O₈ grades within a wireframe model that were estimated by ordinary kriging. The historical estimate was estimated at a cut-off grade of 0.1% U₃O₈ and using an average long-term uranium price of US\$75 per pound. Six zones make up the historical estimate at Matoush: am-15, mt-34, mt-22, mt-02, mt-06, and mt-36. Each zone is made up of one or more lenses, most of which strike north (009°) and dip

steeply (87°) to the east. Outlines of the mineralized lenses were interpreted on ten-metre spaced vertical sections. Minimum criteria of 0.10% U₃O₈ over 1.5 metre true thickness was used as a guide. An exploration program would need to be conducted, including twinning of historical drill holes, in order to verify the Matoush historical estimate as a current Mineral Resource.

For Ben Lomond, as disclosed in the above noted technical report, the historical estimate was prepared by the Australian Atomic Energy Commission (AAEC) using a sectional method. The parameters used in the selection of the ore intervals were a minimum true thickness of 0.5 metres and maximum included waste (true thickness) of 5 metres. Resource zones were outlined on 25 metre sections using groups of intersections, isolated intersections were not included. The grades from the composites were area weighted to give the average grade above a threshold of 500 ppm uranium. The area was measured on each 25 metre section to give the tonnage at a bulk density of 2.603. An exploration program would need to be conducted, including twinning of historical drill holes, in order to verify the Ben Lomond historical estimate as a current Mineral Resource.

For the Milo Project, as disclosed in the above noted scoping study, the historical estimate was prepared by Peter Owens and Basile Dean of Mining One Consultants. An exploration program would need to be conducted, including twinning of a selection of certain holes, along with updating of mining processing and certain cost estimates in order to verify the Milo Project historical resource estimate as a current Mineral Resource estimate.

For the Wiluna Uranium Project, as disclosed in the above-noted ASX announcements, the Mineral Resource Estimate was prepared by the Competent Persons in accordance with the 2012 Edition of the Australasian Code for Reporting of Exploration Results, Mineral Resources and Ore Reserves (JORC Code 2012). The estimate incorporates the Centipede-Millipede, Lake Way, Lake Maitland, Dawson Hinkler and Nowthanna deposits and is based on work completed by Dr. Greg Shirtliff and Mr. Daniel Guibal of Condor Geostat Services Pty Ltd. Mr. Guibal was responsible for the Mineral Resource Estimate and Dr. Shirtliff was responsible for the integrity of the data supplied for the estimation. The Mineral Resource Estimate has not been updated since it was last reported, and IsoEnergy is not aware of any new information or data that materially affects the estimate. All material assumptions and technical parameters underpinning the estimate continue to apply and have not materially changed. An updated Mineral Resource Estimate incorporating additional drilling and any subsequent technical work would be required to verify the historical estimate as a current mineral resource.
