The 2025 work plan is a non impact-causing work program and will include 1) ground-based magnetic and VLF-EM (very low frequency electromagnetic) geophysical surveys, and 2) a biogeochemical survey on black spruce trees collecting approximately 500-1000 samples. A helicopter will only be used for less than 10 days to reach

selected remote locations The project work will take place in discrete areas within a 100-km2 area. The work crew will vary between 10-16 workers.

SECTION 5 – STATUS OF EXPLORATION PROJECT

Summary of previous work

2024 – a non impact-causing work program that included 1) ground-based magnetic, VLF-EM, and ANT (ambient noise tomography) geophysical surveys, and 2) a biogeochemical survey on black spruce trees collecting 600 samples. The work crew varied between 4-10 workers. 2023 – a rock sampling program for 7 days utilizing a helicopter and a crew of 5 workers.
